ARTICLES OF INCORPORATION
(Professional Corporation)
OF

RICHARD J. DuCHARME, P.A.

The undersigned, all of whom are duly licensed to practice law, in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopt the following Articles of Incorporation:

I. NAME

The name of the professional Corporation is RICHARD J. DuCHARME, P.A.

II. PURPOSE

The purpose for which the Corporation is organized is to practice the profession of law.

III. ELECTION UNDER PROFESSIONAL CORPORATION ACT

The Corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

IV. DURATION

The term of existence of the Corporation is perpetual.

V. CAPITAL STOCK

The number of shares the Corporation is authorized to issue is 100 all of which shall be common shares with no-par value.

VI. STATED CAPITAL


The amount of capital with which the Corporation shall begin business is \$2,500.

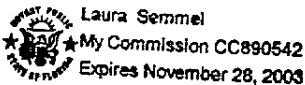
