**ARTICLE I - NAME**

The name of this Corporation is Eirini Pasi, Inc. and the address is 2719 Shoemaker Lane, Mount Dora, Florida 32757.

**ARTICLE II - TERM OF EXISTENCE**

The existence of this Corporation shall exist perpetually.

**ARTICLE III - NATURE OF BUSINESS**
