KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, having associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Florida, do hereby adopt the following Article of Incorporation.

ARTICLE I - NAME

The name of the Corporation is **TRADERSNEST, INC.**

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
