ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is A & M CLASSIC, INC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: Suite 200-4 2700 W. Atlantic Blvd. Pompano Beach, Florida 33069

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
