The undersigned hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a corporation under the Laws of the State of Florida:

**ARTICLE I - NAME**

The name of the corporation shall be Debra S. Hill, P.A. The location of the corporation is 1425 Caddell Road, Jacksonville, FL 32217 and mailing address of the corporation is 1425 Caddell Road, Jacksonville, FL 32217.

**ARTICLE II - DURATION**
