The undersigned, acting as incorporator of Jerron Corp. under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

**ARTICLE III - COMMENCEMENT OF EXISTENCE**

**ARTICLE IV - PURPOSE**

## **ARTICLE V - AUTHORIZED SHARES**
