ARTICLES OF INCORPORATION OF URIEL NAZARIO, M.D., P.A.

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation.

<u>ARTICLE I. NAME</u>

The name of the corporation is Uriel Nazario, M.D., P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 1508 Brookstone Drive, Orange Park, Florida 32073.

ARTICLE III. PURPOSE

The specific nature and purpose of the corporation is the provision of professional medical services.

ARTICLE IV. CAPTIAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock with a par value of \$.01 per share.
