#### ARTICLES OF INCORPORATION

#### BREWED BEGINNINGS, INC.

#### ARTICLE I - NAME

The name of this Corporation is BREWED BEGINNINGS, INC.

#### ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

#### ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activity or business permitted under the laws of the United States and Florida.

#### ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue one class of shares, which should be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive the net assets of the Corporation upon a dissolution. ### ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE XI - AMENDMENT


