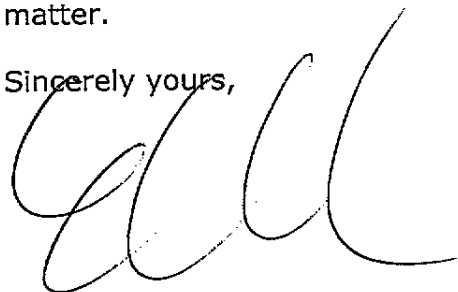

**ARTICLE I—NAME**

The name of this corporation is **CRITICAL DATA SOLUTIONS, INC.**

**ARTICLE II—DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III—PURPOSE**

This corporation is organized for the purpose of providing secure computer data backup and archival services and transacting any or all lawful business.

**ARTICLE IV—CAPITAL STOCK**

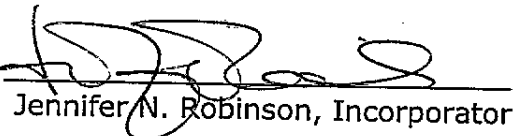
### **ARTICLE IX—INDEMNIFICATION**
