

Preamble

The undersigned to these Articles of Incorporation is a member of The Florida Bar and is an attorney duly licensed to practice law in the State of Florida hereby forms a corporation under the Florida Professional Service Corporation and Limited Liability Companies Act, Chapter 621, Florida Statutes, intending thereby to comply with the Rules and Bylaws of The Florida Bar as promulgated by the Supreme Court of Florida.
