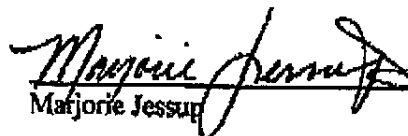
ARTICLE IX - AMENDMENT

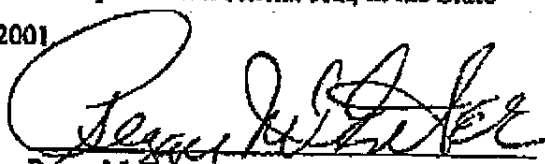
