ARTICLES OF INCORPORATION OF C & J RESCREENING & REPAIRS, INC.

THE UNDERSIGNED, acting as sole incorporator of C & J RESCREENING & REPAIRS, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be C & J RESCREENING & REPAIRS, INC.

<u>ARTICLE II</u>

Shares

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.
