**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
HOME GUARD SERVICES, INC. PEST PREVENTION**

Pursuant to Section 607.1006, Florida Statutes, HOME GUARD SERVICES, INC. PEST PREVENTION, a Florida corporation (the "Corporation"), does hereby amend its Articles of Incorporation by amending Article I as follows:

RESOLVED, that Article I of the Articles of Incorporation of the Corporation are hereby amended as follows:

**"ARTICLE I. NAME**

The name of the corporation shall be Green Frog Services, Inc. Pest Prevention"

Except as amended hereby, the Articles of Incorporation shall remain in full force and effect.

The Board of Directors of the Corporation by joint written action dated April 16, 2002 adopted a resolution recommending the proposed Articles of Amendment to the shareholders for approval. The number of votes by the shareholders cast in favor of the Articles of Amendment was sufficient for approval.
