ARTICLE I - CORPORATE NAME AND MAILING ADDRESS

ARTICLE XIII - INDEMNIFICATION

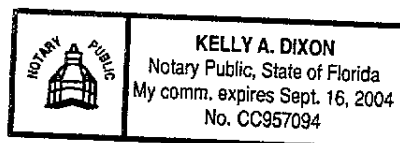
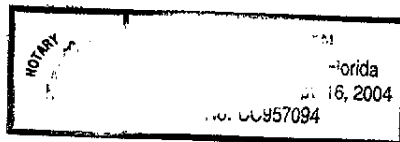
