ARTICLES OF INCORPORATION

OF

INVESTIGATIONS, INC.

The undersigned, desiring to form a corporation under the provisions of the Laws of the State of Florida, hereby make, subscribe and acknowledge before a Notary Public, and file with the secretary of State of the state of Florida, the following Articles of Incorporation for such corporations:

ARTICLE I - NAME

The name of the corporation is: INVESTIGATIONS, INC., and its business shall be carried on in Broward County, Florida, and also within and without the state of Florida and in the United States of America and foreign countries as may from time to time be deemed desirable or expedient.

ARTICLE II - PURPOSE

The general nature of the business to be transacted by this Corporation and the objects and purposes thereof are as follows:

- The transaction of any and all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- To maintain offices in connection with said business and where
 necessary, to build or construct new facilities or additions to existing
 facilities in connection with its business.
- 3. To buy, sell, manufacture, repair, alter and exchange, let or hire, export or deal in all kinds of articles and things which may be required for the purpose of any of the said business or commonly supplied or dealt in by persons engaged in any such business, or which may seem capable of being profitably dealt with in connection with any of the said business.

4. To engage in any activity or business permitted under the laws of the United States and of the state of Florida.

ARTICLE III -- CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time shall be 100 shares of Capital Stock with \$1.00 par value per share.

The capital stock may be paid for in property, labor or services at a just valuation, to be fixed by the Incorporators or by the Directors at a meeting called for such purpose or at the organization meeting. Property, labor or services may also be purchased or paid for with the capital stock at a just valuation of said property, to be fixed by the Directors of the Company. Stock in other corporations or going businesses may be purchased by the Corporation, in return for the issuance of its capital stock, and said purchases shall be on such basis and for such consideration and the issuance of so much of the capital stock as the Directors of the Company may decide.

ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this Corporation shall begin business shall not be less than Five Hundred (\$500.00) Dollars.

ARTICLE V - TERM OF EXISTENCE

The Corporation shall have perpetual existence unless dissolved by action of law or by vote of the stockholders.

ARTICLE X - AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law.

Every amendment shall be approved by the Board of Directors, proposed by them to the

stockholders, and approved at a stockholders' meeting by a majority of the voting shares.

ARTICLE XI - POWERS OF THE BOARD OF DIRECTORS

In furtherance and not in limitation of the powers conferred by Statute, the Board of Directors is expressly authorized:

- 1. To make, aiter, amend or repeal the By-Laws of the Corporation.
- 2. To fix the amount to be reserved as working capital and to authorize and cause to be executed mortgages, liens upon the property, and franchises of this Corporation.
- 3. If the By-Laws so provide, to designate by resolution one or more of their number to constitute an Executive Committee, which Committee, to the extent provided in the resolution or in the By-Laws of the Corporation, shall have and may exercise any or all of the powers of the Board of Directors in the management of the business, affairs and property of the Corporation, during the intervals between the meeting of the Board of Directors, so far as may be permitted by law.


