**ARTICLES OF INCORPORATION
OF
SB MEDIA TECHNOLOGIES, INC.**

These Articles of Incorporation are made and acknowledged by the undersigned Incorporator for the purpose of creating a domestic corporation for profit in accordance with §607.0202 *Florida Statutes*.

ARTICLE I

The corporate name of the corporation shall be **SB MEDIA TECHNOLOGIES, INC.**

ARTICLE II

The address of the principal business office of the corporation shall be 3009 N.E. 19th Street, Fort Lauderdale, Florida 33305. The mailing address shall be the same.

ARTICLE III

The corporation is organized to engage in any lawful act or activity for which corporations may be organized under the provisions of the Florida General Corporation Act. Without limitation of the foregoing, it is anticipated that the initial business of the corporation will be computer and video consulting and programming.

ARTICLE IV

The amount of the total authorized capital stock of this corporation is One Thousand Dollars (\$1,000.00) divided into one thousand (1,000) shares of common stock of the same class. Each share shall have a par value equal to One Dollar (\$1.00). All shares shall confer upon the owners thereof the same rights. No preemptive rights are granted to shareholders.

ARTICLE V

The name of the incorporator is Herbert Boardman. The address of

the Incorporator is 3009 N.E. 19th Street, Fort Lauderdale, Florida 33305.

ARTICLE VI

The number of Directors of the corporation shall be two (2); however, the number of Directors may be changed by amendment of the By-Laws of the corporation. Cumulative voting for Directors shall not be permitted.

ARTICLE VII

The corporation shall have perpetual existence, which existence shall commence upon June 11, 2001.

ARTICLE VIII

The street address of the initial registered office of the corporation shall be 3009 N.E. 19th Street, Fort Lauderdale, Florida 33305. The name of the initial registered agent of the corporation at that office is Herbert Boardman. A written acceptance of such office in accordance with §607.0501(3) *Florida Statutes* accompanies these Articles.

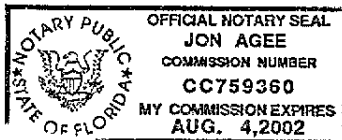
