NAME

DURATION

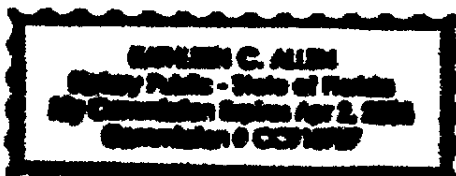
