NAME

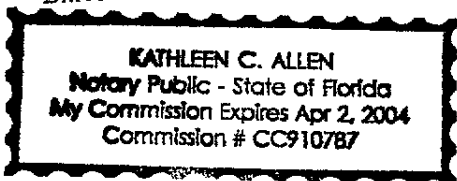
