ARTICLE I NAME

The name of the Corporation is: JUMP THE MOON, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 14015 Highway 301 South, Riverview, Florida 33569.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of therapeutic equestrian activities; and
2.
