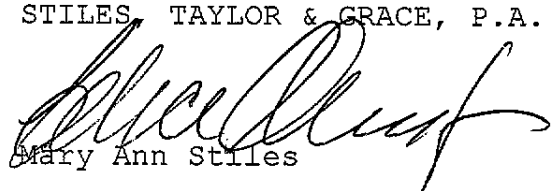

The undersigned, for purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation shall be:

BILL BROWN INVESTIGATIONS, INC.

ARTICLE II

CAPITAL STOCK

This corporation is authorized to issue 1000 Shares at One Dollar (\$1.00) par value common stock.

ARTICLE III
