PREEMPTIVE RIGHTS



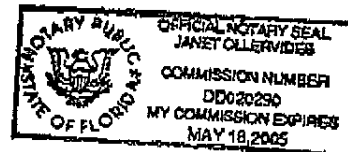
