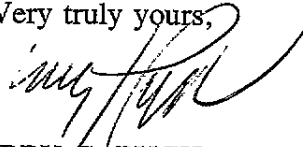

**ARTICLE I - NAME**

The name of this corporation is IRBY G. PUGH, P.A.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Secretary of State, State of Florida.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of practicing law and all activities normally included therewith, including operating a law office, advising and representing clients, and such other lawful public business as may be permitted by the Statutes of the State of Florida.

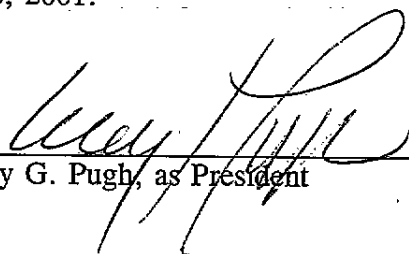
#### **ARTICLE VIII - BYLAWS**

This corporation reserves the right to amend or repeal any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

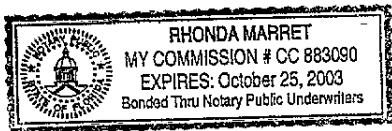

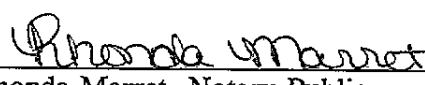

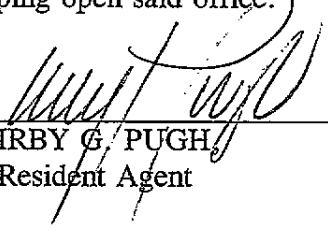
