# ARTICLES OF INCORPORATION

# JIM'S STUFF, INC.

THE UNDERSIGNED subscriber to these ARTICLES OF INCORPORATION, being a natural person competent to contract, does hereby form a corporation for profit under the laws of the State of Florida.

#### ARTICLE I - NAME

THE NAME of this corporation is JIM'S STUFF, INC.

# ARTICLE II - PURPOSE

THE CORPORATION may engage in any activity or business permitted under the laws of the United States and the state of Florida.

# ARTICLE III - CAPITAL STOCK

THE MAXIMUM number of shares of stock that this corporation is authorized to have outstanding at any time is five hundred (500) shares of common stock, each share having the par value of one Dollar (\$1.00).

## ARTICLE IV - DURATION

Its existence on the date these Articles are executed and acknowledged if the same are filed with the Secretary of the State of Florida within five (5) days of said execution. If said Articles are not filed with the Secretary of State of Florida within said five (5) days, the corporation shall commence its existence on the date these Articles are filed with said Secretary of State.

#### ARTICLE V - PRE-EMPTIVE RIGHTS GRANTED

EVERY SHAREHOLDER, upon issuance of any new stock in this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share at the price at which it is offered to others.

#### ARTICLE VI - REGISTERED OFFICE

THE INITIAL registered office of the corporation shall be at 2230 Needle Palm Drive, Edgewater, Florida 32141. The shareholders may from time to time designate another address and place for the registered office of this corporation. - the stockholders of this corporation may approve the reasonable charges and expenses of incorporating this corporation, including attorney's fees and costs and the reasonable expenses and compensation for the sale or underwriting of the shares of this corporation. The same may be allowed to be paid out of the consideration received by the corporation for the issuance of the shares without thereby impairing the fully paid and non-assessable status of such shares.

## ARTICLE IX - STOCKHOLDERS

NO STOCKHOLDER may sell or transfer his shares of stock except to another individual who is eligible to be a stockholder of this corporation. - b) TO PURCHASE and acquire any or all of its shares owned and held by any such stockholder as should desire to sell, transfer, or otherwise dispose of his shares, or any or all of its shares owned and held by a stockholder who dies; provided, however, that the capital of this corporation shall not be impaired thereby.
- c) TO ENTER into, for the benefit of its employees, one or more of the following:
  - 1) a pension plan

  - 5) a restricted stock option plan
  - 6) or other retirement or incentive compensation plan
