# ARTICLES OF INCORPORATION $\mathbf{OF}$

SECRETARY MAY BE 34 The undersigned subscriber to these Articles of Incorporation, Fredrick J. Svenson, be a natural person competent to contract, hereby acknowledges and files theses ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the provisions of Chapter 607, Florida General Corporation Act and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes does hereby adopt the following Articles of Incorporation.

## ARTICLE I

## CORPORATE NAME

The name of this professional service corporation is Quality Homes Carpentry, Inc. The principal and mailing address of the corporation is 310 Wilson Boulevard S., Naples, FL 34117

#### <u>ARTICLE II</u>

### **DURATION**

This professional service corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

#### <u>ARTICLE III</u>

#### **PURPOSE**

The general nature and purpose of the business to be transacted, promoted and carried on by the corporation are as follows:

- To engage in every aspect of the practice of carpentry and all its fields of specializations, as are engaged in by carpenters.
- To engage and render professional services involved only through its officers, **b**. agents and employees who shall be Licensed carpenters in good standing and duly licensed authorized within the State of Florida to render the same professional service as this corporation.
