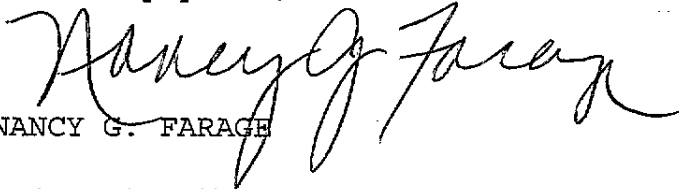

NATURE OF BUSINESS

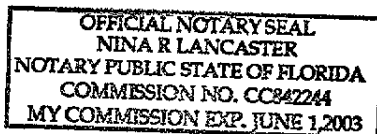
