1. The current name of the Corporation is MULTISTAFF SOLUTIONS, INC.
2. The date of the filing of the original Articles of Incorporation of the Corporation was June 12, 2001.
3. The Articles of Incorporation of the Corporation are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:

ARTICLE I – Name of Corporation

The name of this corporation shall be MedTeam Staffing, Inc.
