# ARTICLES OF INCORPORATION OF

**Martin A. Grossman, DC, PA**

The undersigned, desiring to form a corporation for the practice of medicine, in accordance with Chapter 621 of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

## ARTICLE ONE NAME

The name of the corporation is Martin A. Grossman, DC, PA (the "Corporation").

## ARTICLE TWO PURPOSE

The purposes for which the Corporation is organized are as follows:

1. To engage primarily in the specific business of the practice of chiropractic medicine as a medical professional corporation;
2. To engage generally in the business of a medical professional corporation as the same is now or hereafter defined by statute, rule and regulation, and in connection therewith to own property, to enter into contracts, and to transact any lawful business related thereto;
3. To engage in such other business as may be authorized or permitted by Chapter 621 of the Florida Statutes.

## ARTICLE THREE PRINCIPAL OFFICE

The principal office of the Corporation shall be located at 3111 Ponce de Leon Blvd., Coral Gable, Florida 33134.

## ARTICLE FOUR REGISTERED AGENT

The registered agent for the Corporation shall be Martin A. Grossman, DC, 3111 Ponce de Leon Blvd., Coral Gables, Florida 33134.

## ARTICLE FIVE DIRECTORS

The Corporation shall initially have one director, which number may be increased or decreased pursuant to the bylaws of the Corporation but shall never be fewer than one.

The amount of stated capital with which the Corporation shall begin business is Ten Dollars (\$10.00).

**ARTICLE EIGHT  
DURATION**

The duration of the Corporation shall be perpetual.
