CERTIFICATE OF INCORPORATION
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE I.

The name of the corporation shall be:

Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as authorized by the Board of Directors.

ARTICLE II.

The general nature of the business to be transacted by the corporation shall be;

To buy and sell all items as they relate to Computers, to sell refilled Ink Cartridges, to offer all services as they relate to the use of Computers.
