#### ARTICLES OF INCORPORATION

OF

### BADENCORP, INC.

The undersigned, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

## ARTICLE I.

The name of this Corporation shall be:

## ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence upon filing with the Secretary of State office, and shall have perpetual existence unless sooner dissolved according to law.


