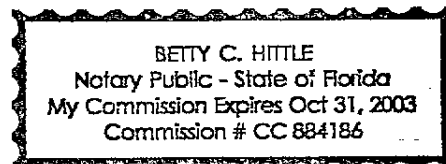

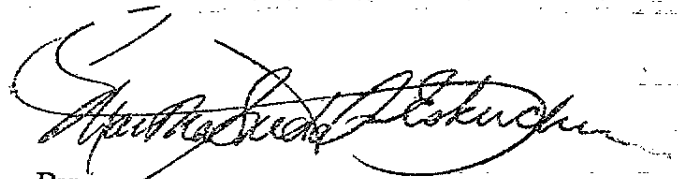
## STATEMENT OF ACCEPTANCE AS REGISTERED AGENT
