ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is FLON-RIGHTS, INC. and its principal place of business shall be located at 1406 Hays St., Suite 2, Tallahassee, FL 32301.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue Twenty (20) shares of common stock at FIFTY THOUSAND US Dollars (\$50,000.00 US) for a total of \$1,000,000 US, par value, which shall be designated as "Common Shares."

ARTICLE VII - DIRECTORS

Initially, this corporation shall have one (1) Director who shall serve until his successor(s) shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than one (1) director constituting the initial Board of Directors. The number of
