ARTICLE I

Corporate Name & Address

The name of the corporation shall be DSL of Broward, Inc. and the address is P.O. Box 451512 Sunrise, Fl 33345-1512

ARTICLE II

Term of Existence

The duration of the corporation is perpetual, to be commenced with the filing of these articles of incorporation with the Department of State of the State of Florida.

ARTICLE III

Nature of Corporate Business



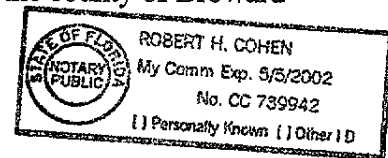
