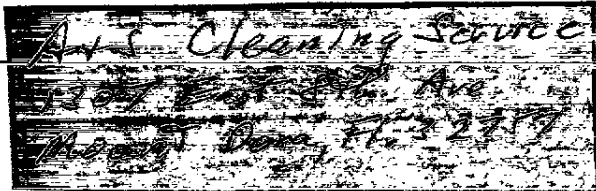

ARTICLES OF INCORPORATION

FIRST: The name of this corporation shall be
A & S Cleaning Service Inc.

SECOND: The existence of the Corporation shall be perpetual.

THIRD: The nature of the business and the objects and purposes to be transacted, promoted and carried on are to engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act.

FOURTH: The amount of total authorized capital stock of the Corporation shall be divided into sixty (60) shares with no-par value.

FIFTH: The street address of the Initial Registered Office shall be,

SEVENTH: The number of Directors constituting the initial Board of Directors shall be two (2). The names and addresses of the persons who shall serve as members of the initial Board of Directors are as follows: Susan Burhenne-1307 East 8th. Ave Mount Dora, FL 32757

EIGHT: The name and address of the person signing these Articles of Incorporation as Incorporator is: Susan Burhenne-1307 East 8th. Ave Mount Dora, FL 32757

NINTH: All of the Corporation's issued stock, exclusive of treasury shares, shall be held of record by not more than thirty persons.

TENTH: All of the issued stock of all classes shall be subject to the following restriction on transfer. Each stockholder shall offer to the Corporation or to other stockholders of the Corporation a thirty (30) day "first right" option to purchase his stock should he elect to sell his stock.

ELEVENTH: The Corporation shall make no offering of any of its stock of any class which would constitute a "public offering" within the meaning of the United States Securities Act of 1933, as it may be amended from time to time.

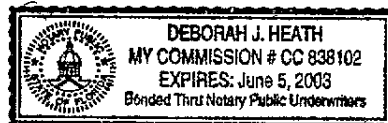

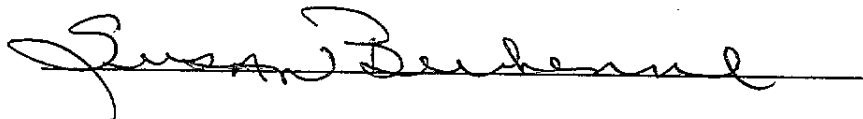
