**ARTICLES OF INCORPORATION  
OF

The undersigned hereby organize a corporation for profit under the provisions of the Florida General Corporation Act, and pursuant to the following Articles of Incorporation.

**ARTICLE I**

**Name**

The name of this corporation is:

**Duration**

This corporation shall have perpetual existence, commencing upon filing.

**ARTICLE III**

**Purpose**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV**

**Capital Stock**

This corporation is authorized to issue One Million (1,000,000) shares of common stock with zero par value.

## **ARTICLE V**

### **Preferences, Privileges, Restrictions and Rights**

**Indemnification**


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
