ARTICLES OF INCORPORATION
OF
Natural Healing and Wellness, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Natural Healing and Wellness, Inc.

ARTICLE II

The existence of the Corporation shall begin on June 12, 2001 and shall continue thereafter in perpetuity.
