**ARTICLES OF INCORPORATION  
OF  
CRAIG CHARLES BUCCERONI, P.A.**

The undersigned, acting as incorporator under and by virtue of the laws of the State of Florida, and particularly the Florida General Corporation Act, as provided in Chapter 607, Florida Statutes, and any acts supplementary thereto, adopts the following Articles of Incorporation for such corporation.

**ARTICLE I**

The name of the corporation shall be: **CRAIG CHARLES BUCCERONI, P.A.** and its principal office and mailing address shall be:

**ARTICLE II**

The location of its initial registered office in the State of Florida is C/O KELLY & KELLY CPA'S, PA. 3020 N. FEDERAL HWY, SUITE 11B, FT. LAUDERDALE, FL 33306 but it shall have the power to establish and maintain branch offices at such cities and towns in the State of Florida and the United States as said corporation may from time to time determine. **ARTICLE III**

The corporation may engage in any activity or business permitted under the laws of the State of Florida and of the United States, and to sell Real Estate.

**ARTICLE IV**
