**ARTICLE I**

The name of this Corporation is:

**ARTICLE II**

This Corporation shall exist in perpetuity commencing on the date of execution and acknowledgement of these Articles of Incorporation.

**ARTICLE III**

This Corporation is authorized to issue 10,000 shares of \$1.00 par value common stock which shall be designated as "Common Shares."
