#### ARTICLE IX - INCORPORATOR

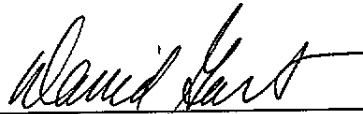

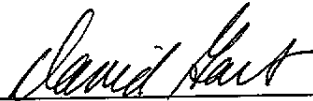
