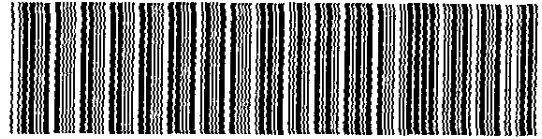

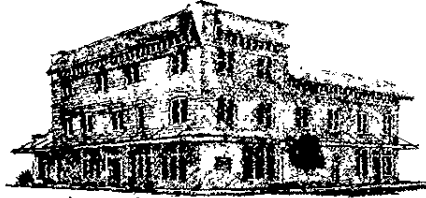

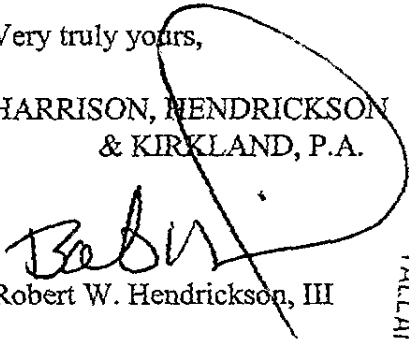

Pursuant to Section 607.1403, Florida Statutes (2002), JKMB Company, a Florida corporation (the "Corporation"), hereby files its Articles of Dissolution and states that:
