The undersigned incorporator, MICHAEL A. SASSANO, III, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

## **ARTICLE I - NAME**

The name of this corporation is TRUS II CONSULTING CORPORATION.

## ARTICLE II - PRINCIPAL OFFICE
