The undersigned subscriber to the Articles of Incorporation being a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

#### **ARTICLE I**

#### Name

The name of this corporation is GEORGIA I-85 MANAGEMENT COMPANY, INC..

# <u>ARTICLE II</u>

#### **General Nature of Business**

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the State of Florida.

#### **ARTICLE III**

#### Capital Stock

The corporation is authorized to issue 1,000 shares of Class A common stock and 1,000 shares of Class B common stock. All stock shall have a par value of one mil (\$.001) per share. This corporation shall exist perpetually, commencing upon filing of these Articles.
