The undersigned subscriber hereby files these Articles of Incorporation with the Secretary of State of the State of Florida, for the purpose of forming a corporation for profit in accordance with the Florida Business Corporation Act, Chapter 607 of the Florida Statutes.

#### ARTICLE I NAME AND MAILING ADDRESS OF CORPORATION

The name of this corporation is TBR, Inc. (the "Corporation"). The mailing address of the Corporation is 726 Northeast First Street, Gainesville, Florida 32601.

### ARTICLE II CAPITAL STOCK

The Corporation is authorized to issue 10,000 shares of \$.01 par value common stock.

#### ARTICLE III CORPORATE EXISTENCE AND DURATION

The period of duration of the Corporation shall be perpetual commencing on June 1, 2001.
