This corporation may engage in any real estate business permitted under the laws of the United States of America and the laws of the state of Florida.

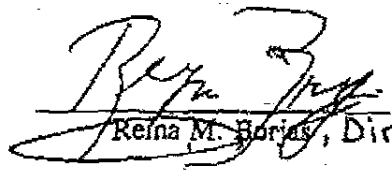
