Articles of Incorporation

ARTICLE I. CORPORATE NAME

The name of this Corporation is Dala A. Zinober, PA.

ARTICLE II. CORPORATE PRINCIPAL OFFICE AND MAILING ADDRESS

The Corporation principal office and mailing address is 413 Mississippi Ave., Palm Harbor, FL 34683.

ARTICLE III. NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is to engage in a professional service as real estate agents permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK


The maximum number of share of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock without par value.

ARTICLE V. TERMS OF EXISTENCE

This Corporation shall have perpetual existence commencing upon these articles filed.

**ARTICLE VI. REGISTERED AGENT AND INITIAL REGISTERED OFFICE
AND ACCEPTANCE BY THE REGISTERED AGENT**

The Registered Agent and the street address for the Initial Registered Office of this Corporation in the State of Florida shall be Dala A. Zinober at 413 Mississippi Ave., Palm Harbor, FL 34683. Directors from time to time may move the Registered Office to any other address in the State of Florida. " I hereby am familiar with and accept the duties and responsibilities as Registered Agent for said Corporation. "



ARTICLE VII. BOARD OF DIRECTOR (S)

This Corporation shall have two Director(s) initially. The number of Director(s) may be increased or decreased from time to time by bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE VIII. INITIAL DIRECTOR (S)

The name of the initial director(s) of this Corporation and their street address is Dala A. Zinober and Tina E. Chaffin at 413 Mississippi Ave., Palm Harbor, FL 34683. The person named initial director shall hold office for the first year of existence of this Corporation or until their successor is elected or appointed and has qualified whichever occurs first.

ARTICLE IX. INCOPORATOR

The name and street address of the person signing these Articles of Incorporation, as the Incorporator is Dala A. Zinober at 413 Mississippi Ave., Palm Harbor, FL 34683.

ARTICLE X. AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholders' meeting by at least a majority of the stock entitled to vote, unless all of the directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE XI. PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his or her pro-rate share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE XII. INDEMNIFICATION

This Corporation shall indemnify any officer or director or any former officer or director, to full extent permitted by law.
