The undersigned does hereby associate himself into a corpo under Chapter 607 of the laws of the State of Florida and does hereby certify as follows:

- 1. The name of the Corporation is EAKY, Incorporated and the address of the principal office of this corporation shall be 4000 North Federal Highway, Suite 201, Boca Raton, Florida 33431. The mailing address of the corporation shall be the same.
