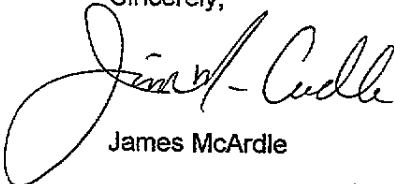
I hope this information provides you with the assurance you need to accept the enclosed articles of amendment and to transfer the trademark as requested.

An amendment has been adopted to change the name of the Corporation from:

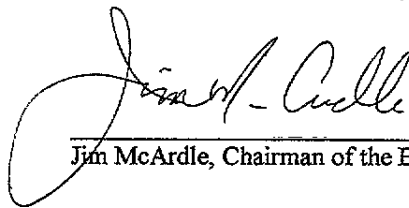
