**ARTICLES OF INCORPORATION**  
**OF**

I, Mark Goldberg, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge, and file the following Articles of Incorporation for the purpose of creating a corporation under the Laws of the State of Florida.

**ARTICLE I**

The name of the corporation shall be: Samor Inc.

**ARTICLE II**

This corporation may engage in any activity or business permitted under the Laws of the State of Florida.

**ARTICLE III**

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

*100 shares common stock, no par value*

All of said stock shall be payable in cash, property, real or personal, labor, or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this corporation. The payment thereof does not have to be at the time of issuance, provided that said shares are subject to calls thereon until the whole consideration therefor shall have been paid.

The amount of capital with which this corporation shall commence business shall not be less than \$500.00.

This corporation is to exist perpetually.

The Board of Directors may from time to time move the principal office to any other address in Florida.

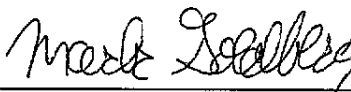
#### **ARTICLE VII**

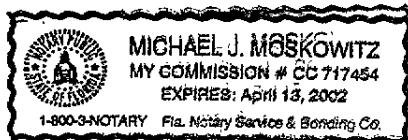
