ARTICLES OF INCORPORATION OF TOOL MARKET PLACE, INC

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

Article I NAME AND ADDRESS

- Section 1.1. Name. The name of the corporation is Tool Market Place, Inc.
