ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation shall be:

FEDERAL COMPUTER SERVICES, INC ARTICLE II

The nature of the business to be transacted is as follows:

To conduct, carry on, operate and engage in the business of computer services, including but not limited to repair, upgrade, purchasing, sale, support and installation of computer hardware and software.

To acquire, by purchase, lease or otherwise, lands and interest in lands, to own, hold improve develop and manage any real estate so acquired, and to erect or cause to be erected buildings and other structures. To encumber or dispose of any lands or interests in lands and any buildings or other structures, at any time.

To acquire, by purchase, lease, or otherwise, any personal property deemed necessary or useful in the corporation.

To buy and sell all kinds of property, both real and personal, to borrow money, issue promissory notes and other evidence of indebtedness, to own, buy, mortgage, sell or otherwise dispose of and deal in and with property of all kinds as well as capital stock and shares of this corporation and that of other corporations, and to vote any share of such other corporation as may be owned by it, the same as a natural person might do.

To carry on any or all of its operations and businesses and to promote its objects within the State of Florida or elsewhere, without restriction as to place or amount, and to have, use, exercise and enjoy all the general powers of like corporations.

To engage in or carry on any business activity or commercial enterprise which is lawful under the laws of the State of Florida and the laws of the United States of America.

The intention is that none of the objects and powers as hereinabove set forth, except where otherwise specified in this Article shall be in anywise limited or restricted by reference to or inference from the terms of any other objects, powers or clauses of this Article or any other Article in this certificate, but that the objects and powers specified in each of the clauses in the Article shall be regarded as independent objects and powers.

The Maximum number of shares of capital stock that this corporation is authorized to have outstanding at any one time is one thousand (1000) shares of common stock of One Dollar (\$1.000) par value. Each shareholder, upon the sale for cash or any other consideration of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issue of fractional shares) at the price at which it is offered to others.

The capital stock may be paid for in cash, property, or labor.

This corporation is to begin operation with not less than \$500.00 capital.
