Corporate Name and Principal Office

The name of this corporation is Electrowave Studios, Inc. and its principal office and mailing address is 1756 Kirtley Drive, Brandon, Florida 33511.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence upon the filing of these Articles with the Florida Department of State.

General Nature of Business
